

Regular Meeting Minutes

Call to Order

Adoption of the Agenda

Chair Malec made a motion to adopt the ANC's regular June 2023 meeting agenda. Commissioner Omictin seconded the motion, which was adopted by unanimous consent.

Adoption of Past Meeting Minutes

Matters Before the Alcoholic Beverage and Cannabis Administration

<u>District Champagne – Application to Transfer the Establishment's Retailer's Class "A" Liquor</u> <u>Store License from 1301 9th Street NW to a New Location at 2400 M Street NW</u>

Chair Malec made a motion to adopt a proposed resolution regarding the matter. Commissioner Comer seconded the motion. A roll call vote was requested. The motion was voted on and passed (VOTES: 7-0-0). The roll call vote was as follows:

<u>Mary's Café – Application for a New Retailer's Class "C" Restaurant License at 2554 Virginia</u> <u>Avenue NW</u>

Matters Before the State Health Planning and Development Agency

<u>Certificate of Need Application by West End Plastic Surgery for the Renovation and Expansion</u> of the Practice's Existing Elective Cosmetic Surgery Facility at 2440 M Street NW

Chair Malec made a motion to adopt a proposed resolution regarding the matter. Commissioner Omictin seconded the motion. A roll call vote was requested. The motion was voted on and passed (VOTES: 7-0-0). The roll call vote was as follows:

Matters Before the DC Council

<u>Consideration of a Resolution Regarding DC Council Bill B25-0056 – the "Dram Shop</u> <u>Clarification Amendment Act of 2023"</u>

Commissioner Patel made a motion to adopt a proposed resolution regarding the matter. Chair Malec seconded the motion. A roll call vote was requested. The motion was voted on and passed (VOTES: 5-2-0). The roll call vote was as follows:

The resolution reads as follows:

WHEREAS, on May 1, 2023, Councilmembers Brooke Pinto and Christina Henderson introduced B25-0056, the "DramShop Clarification Amendment Act of 2023" (dramshop),"

WHEREAS, the definition of an "intoxicated" individual would be revised, placing the burden of judgment on the server/bartender to determine if a patron is drunk,

WHEREAS, the bill would remove civil liability from an establishment to any injured individual or their estate as result of being drunk, which would result in the following:

- Make claims of injury that result from a drunk offender harder to bring to court,
- Establishments will have less incentive to make sure patrons are not leaving intoxicated,

WHEREAS, there would be a cap for civil damages should a case be filed in the amount of \$250,000 if any action of harm is committed by a patron towards an individual,

WHEREAS, the training and support from management that bartenders and servers rely on in regards to alcohol service would disappear, and

WHEREAS, this bill will violate the spirit of Vision Zero and will be in direct conflict and opposition to it, as it will make our streets more dangerous for pedestrians, bicyclists, and drivers.

THEREFORE, BE IT RESOLVED that ANC 2A encourages the members of the DC Council to oppose this bill.

<u>Consideration of a Resolution Regarding DC Council Bill B25-0280 – the "Workers and</u> <u>Restaurants Are Priorities Act of 2023"</u>

Commissioner Courtney made a motion to table the matter. Commissioner Comer seconded the motion. A roll call vote was requested. The motion was voted on and did not pass (VOTES: 3-2-2).

Commissioner Omictin: Yea Chair Malec: Nay Commissioner Patel: Nay Commissioner Courtney: Yea Commissioner Bandy: Abstain Commissioner Nassar: Abstain Commissioner Comer: Yea Commissioner Patel made a motion to adopt a proposed resolution regarding the matter. Chair Malec seconded the motion, which was voted on and passed (VOTES: 3-2-0). The roll call vote was as follows:

The resolution reads as follows:

WHEREAS, on November 8, 2023, DC voters passed Initiative 82 (I-82), a referendum that would phase out the subminimum or tipped minimum wage by 2027, meaning that workers receiving tips would be entitled to the full minimum wage in their base pay before tips,

WHEREAS, on May 1, 2023, Councilmember Kenyan McDuffie introduced B25-0280, the "Workers and Restaurants Are Priorities (WRAP) Act of 2023,"

WHEREAS, Councilmember McDuffie's legislation would alter the incremental wage increase timeline passed by voters in I-82 by canceling the scheduled increase from \$8 to \$10 per hour in 2024 and implementing full wage parity, to roughly \$17 per hour, in 2025 instead of 2027,

WHEREAS, Councilmember McDuffie's legislation incentivizes the use of service charges in restaurants by removing sales tax on service charges that contribute directly to the base pay of tipped workers and relaxing requirements by restaurants to report the reason they are imposing a service charge,

WHEREAS, Councilmember McDuffie's legislation would allow restaurants to charge up to a 22% service charge to customers,

WHEREAS, ANC 2A is home to many restaurants with tipped workers, and restaurant patrons in our ANC are often from outside DC, and

WHEREAS, the confusing service charge model, charging more on the end of a bill without a clear indication of the charge's purpose, would lead customers to believe they are paying an auto-gratuity or otherwise paying for an employee's wages beyond their base pay.

THEREFORE, BE IT RESOLVED that ANC 2A opposes the "Workers and Restaurants Are Priorities Act of 2023" as currently written on the basis that it will harm small restaurants that are not yet ready to make the full jump to the full minimum wage for their tipped workers, confuse and discourage restaurant patrons from dining in DC, and reduce tips for restaurant workers.

BE IT FURTHER RESOLVED that ANC 2A believes that the DC Council should adjust the "Workers and Restaurants Are Priorities Act of 2023" in the following ways:

- Encourage or require service charges to be passed on entirely to workers as a supplement to base pay,
- Strengthen restaurants' obligations to clearly explain service charges to customers,
- Encourage restaurants to implement minimum wage parity faster without changing the wage increase schedule passed by the voters in I-82,
- Outline a robust public education campaign around the subminimum wage increase and service charge laws in DC, and
- Avoid unfair preferential treatment for restaurants over all other commercial entities and retailers in the District.

<u>Consideration of a Resolution Regarding DC Council Bill B25-0152 – the "Reparations</u> <u>Foundation Fund and Task Force Establishment Act of 2023"</u>

Chair Malec made a motion to table the matter until the ANC's regular July 2023 meeting. Commissioner Courtney seconded the motion, which was adopted by unanimous consent.

Consideration of a Resolution Regarding DC Water

Chair Malec made a motion to table the matter until the ANC's regular July 2023 meeting. Commissioner Omictin seconded the motion, which was adopted by unanimous consent.

<u>Adjournment</u>
