

1 **WHEREAS**, on February 21, 2024, ANC 2A (“Commission”) voted on the 2024 performance
2 oversight resolution on the DC Department of Transportation (DDOT),
3

4 **WHEREAS**, the DC Department of Transportation (DDOT) has the core and critical objective
5 of maintaining the infrastructure in a state of good repair for the health and safety of the public,
6

7 **WHEREAS**, ANC 2A hosted several Sidewalk Palooza events over a four-year period, so that
8 residents all at once could enter 311 and TSI requests around infrastructure and traffic safety,
9

10 **WHEREAS**, Mayor Bowser’s Capital Improvements Budget has outlined priorities from Fiscal
11 Year (FY) 2025-2028 that are split between the Department of Parks and Recreation (DPR), DC
12 Water, and DDOT,
13

- 14 • \$129.6 million for sidewalks, alleys, stormwater and flood mitigation¹,
- 15 • funding targeted for streetscapes, beauty modification, and safety improvements,
- 16 • \$40 million for parks, athletic fields, and playgrounds,
17

18 **WHEREAS**, in ANC 2A the lack of timely and proper maintenance of the residential alley that
19 is the Snows Court corridor throughout the years could result in the loss of housing stock,
20

21 **WHEREAS**, Councilmember Pinto created the Snows Court Task Force after touring the Snows
22 Court corridor in response to ANC 2A’s performance² and budget oversight³ resolutions for
23 Fiscal Year 2024 (FY 2024) around the numerous issues plaguing the Snows Court corridor to
24 numerous agencies,

25

26 **WHEREAS**, ANC 2A has the following parks that require tiered-out budget funding:

27

- 28 • 26th & I Street Dog Park/Playground
- 29 • Francis Field Park

30

31 **THEREFORE, BE IT RESOLVED** that ANC 2A wants any and all projects meeting the
32 capital improvements criteria to be funded from FY 2025 through FY 2028.

33

34 **THEREFORE, BE IT FURTHER RESOLVED** that ANC 2A wants DDOT to prioritize with
35 urgency all outstanding service requests around repairing/updating sidewalks within the
36 Commission’s boundaries.

37

38 **THEREFORE, BE IT FURTHER RESOLVED** that ANC 2A wants DDOT to outline a plan
39 to mow and maintain properties that it owns along Virginia Avenue, and to replace important
40 signs that were removed as they were broken.
