Call to Order

Adoption of the Agenda.

Adoption of Past Meeting Minutes.

Matters before the Commission of Fine Arts

The ANC adopted a resolution to support before the Commission of Fine Arts the request of Bay Atlantic University., to add signage, a canopy and outside tables and seating to a café at 1510 H Street. The resolution was adopted by unanimous consent. The ANC also adopted a resolution to support an application by Bay Atlantic University at 1510 H Street, NW before the District

Department of Transportation for sidewalk seating with guardrails. The resolution was adopted by unanimous consent. The ANC adopted a resolution to support this application before the Office of Historic Preservation. The resolution was adopted by unanimous consent.

Matters before the DC Council

1. The Commission adopted a resolution by Commissioner Chadwick, CR 24-023, regarding heating timelines for multiunit buildings by unanimous consent.

2. The Commission adopted a resolution by Chair Patel, CR 24-024, regarding budget priorities, including an amendment adding the Foggy Bottom library and Village, by unanimous consent.

3. The Commission adopted a resolution by Chair Patel, CR 24-025, regarding Aston budget priorities, by unanimous consent.
