RE: DC Department of Transportation Department Oversight Performance 2025

At its regular meeting on April 15, 2025, Advisory Neighborhood Commission 2A ("ANC 2A" or "Commission") considered the above-referenced matter. With all six commissioners present, a quorum at a duly-noticed public meeting, the Commission, after a motion made by Commissioner Patel and seconded by Commissioner DiCapo, adopted the following resolution by unanimous consent:

WHEREAS, the DC Department of Transportation (DDOT) has the core and critical objective of maintaining the city's infrastructure in a state of good repair, for the health and safety of the public;

WHEREAS, ANC 2A ("the Commission") hosted several "sidewalk palooza" events over a four-year period, so that residents could, all at once, enter 311 and TSI requests pertaining to infrastructure and traffic safety;

WHEREAS, Snows Court residents have observed cracks in their buildings' walls and evidence of sinking foundations which they believe may relate to ongoing water issues;

WHEREAS, Councilmember Pinto created the Snows Court Task Force after touring the Snows Court corridor in response to ANC 2A's performance and budget oversight resolutions for Fiscal Year 2024 (FY2024), which delineated numerous issues plaguing the Snows Court corridor to numerous agencies;

WHEREAS, The Department of Public Works (DPW) does not provide the same essential services to this corridor as are provided to street-facing properties, such as regular street sweeping, leaf collection and snow surface treatment;

THEREFORE, BE IT RESOLVED that ANC 2A requests that the D. C. Council recognize the Snows Court Corridor through being granted the designation of a "residential alley."

THEREFORE, BE IT FURTHER RESOLVED that ANC 2A wants the D.C. Council to work in collaboration with the Snows Court Task Force to provide full transparency along with a timeline for urgent and necessary maintenance projects involving the Snows Court corridor,


