RE: ANC 2A Aston Capacity Response to Councilmember Pinto

WHEREAS, Advisory Neighborhood Commission 2A (“ANC 2A” or “the Commission”) passed the *Department of Human Services (DHS) Budget Oversight Resolution for Fiscal Year 2026* on June 18, 2025;

WHEREAS, ANC 2A received a [response](#)¹ from Ward 2 Councilmember Brooke Pinto to the above-referenced resolution on October 9, 2025;

WHEREAS, The Aston is currently capped indefinitely at a total of 100 residents pursuant to an agreement² signed on July 6, 2023, by Councilmember Brooke Pinto and representatives of Mayor Muriel Bowser’s administration;

WHEREAS, it has been reported that The Aston has the space and capacity to house up to 190 residents³;

WHEREAS, Councilmember Pinto stated in her correspondence, “*There are concerns about the feasibility of increasing the existing capacity with the current budget while maintaining the high quality of services for residents*”;

WHEREAS, Commissioner Youngstone responded the same day, respectfully requesting that the Councilmember “*identify some concrete targets The Aston could work towards in order to secure her support for expansion, so that the cap becomes dependent on performance instead of remaining as an arbitrary ceiling*”;

WHEREAS, Deputy Mayor Wayne Turnage stated during a June 9, 2025 oversight hearing⁴ that the District needs to find ways to make more beds available;

WHEREAS, recent federal decisions have placed significant economic pressure on the District’s FY2026 budget cycle, creating a shortfall amounting to hundreds of millions of dollars⁵;

WHEREAS, in September 2025, *The Way Home Campaign* sent a [letter](#)⁶ to Mayor Muriel Bowser and Councilmember Pinto urging expansion of bridge housing, specifically The Aston;

WHEREAS, on October 15, 2025, *The Way Home Campaign* launched a citywide [sign-on letter](#) again calling for the expansion of The Aston;

WHEREAS, in her October 21, 2025 response to ANC 2A, Councilmember Pinto further stated, *“The success of this model is in part built on the consensus of the community, government partners, and those running the facility on the number of people served at a site”*;

THEREFORE, BE IT RESOLVED, that ANC 2A respectfully requests a clear and transparent response from Councilmember Pinto to Commissioner Youngstone’s question identifying specific goals and targets that the Department of Human Services (DHS) should meet in order to lift the current cap;

BE IT FURTHER RESOLVED, that ANC 2A does not support an indefinite cap on the number of residents at The Aston;

BE IT FURTHER RESOLVED, that ANC 2A requests a briefing from Deputy Mayor Wayne Turnage and DHS Director Rachel Pierre regarding The Aston’s first year of operations;

BE IT FINALLY RESOLVED, that ANC 2A recommends that the capacity at The Aston be gradually increased toward a new cap of 190 residents, progressing through intermediate targets of 150 and 190, as was done in the previous increments of 50 and 100, to ensure continued high-quality service for all residents.
